## TERMS AND CONDITIONS OF SALE

This order is accepted on the following terms and conditions. "Subject Matter" shall mean all material or information provided to QCA, Inc. by Customer in whatever form whether intended to be embodied or contained in CDs, Cassettes, and Records or not.

**ACCEPTANCE OF ORDERS:** Customer expressly warrants that it is authorized to provide the Subject Matter to QCA for mastering, processing, duplication and packaging and further warrants that it possesses all rights in the Subject Matter, including but not limited to all copyrights, patents, trademarks, trade secrets and other intellectual property necessary or beneficial to QCA's production of goods containing the subject matter and all related mastering, processing, duplication and packaging. QCA reserves the right to refuse any orders. All orders will be promptly acknowledged.

**TERMS:** Terms are 50% with order, balance on or before delivery unless stated otherwise. 1 1/2% per month will be charged on all past due accounts. All prices are F.O.B. Cincinnati, Ohio. In the event the customer fails to pay within 120 days for any work completed, the company has the right to sell, dispose of or use any such material on hand, in any way the company chooses. All materials used in production of the order such as negatives, master tapes, trademarks, etc., become the property of QCA.

**DELAYS:** While the company will do everything possible to meet promised delivery dates such as indicated on acknowledgments of order, these are only estimated dates of delivery and the company disclaims liability for delays in shipment.

**RETURNED GOODS**: No goods are to be returned for any reason without written authorization from QCA. All goods for which a return is authorized shall be returned at the customer's expense. Any authorized return shall include a detailed, written description of the alleged error or defect which is sufficient to permit QCA to verify the presence, nature and extent of the defect. Where such a factory defect is confirmed by QCA, product will be remade free of defect or a credit will be issued at QCA's sole discretion. The credit to be given shall not exceed the customer's actual sales price paid and freight charges incurred by customer in shipping the goods from QCA to the first delivery point. Our count or audit in respect to returned goods shall be final and binding.

**CLAIMS:** The company is not responsible for breakage, damage or shortage after goods are delivered to transportation company. Claims based thereon must be made directly to the transportation company by the customer. All other claims must be made within 5 days from receipt of merchandise. Where customer makes no such claim, the shipment shall be conclusively presumed to be acceptable.

**RESPONSIBILITY:** The company accepts no responsibility for materials held in stock. Customer is liable for fees arising from shipping or collecting for the merchandise. Company acts only as a sub-contractor for the customer and will not be liable or responsible for royalties, talent fees, copyrights, excise taxes or other expenses involved through the production and/or distribution of customer's records.






